5. Pre-bid meeting shall be held at Nepal Police Hospital Maharajgunj, Kathmandu, Nepal at 19th October 2023 at 12:00 hours NST.

Electronic bids must be submitted to the office Nepal Police Hospital, Maharajgunj, Kathmandu, Nepal through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours NST on 03<sup>rd</sup> November, 2023**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours NST on **03<sup>rd</sup> November, 2023 at the office of Nepal Police Hospital Maharajgunj, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
8. All mention Contract ID No. of Medical's Equipment items evaluation will be done individual group package wise.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
